

LEGAL: Best Dog Day Ever – Home Edition (the “Event”) is organized by Group Nine Media, Inc. (“Group Nine”). By registering for and/or attending the Event, you (the “Attendee”) accept the Group Nine Terms and Conditions, available at <https://www.grouppinmedia.com/tscs>, and the Group Nine Privacy Policy, available at <https://www.grouppinmedia.com/privacy> (collectively the “Event Terms”) as acknowledged during the RSVP process. Each Attendee also agrees to follow the rules and regulations of the Platforms (defined below); and registration, use of login credentials/link, or attendance at the Event shall be considered acknowledgement of, and agreement to, these terms and conditions and any other terms and conditions posted on this website or at the Event.

Attendee voluntarily assumes all risks incidental to the Event, including bodily injury and death, and damage to property, whether occurring prior to, during, or following the Event.

Attendee releases, indemnifies and holds harmless Group Nine Media, Inc., the virtual platforms on which the Event will occur and be streamed (the “Platforms”), and each of their respective subsidiaries, affiliates, officers, employees, representatives, and agents, and each of their respective assignees and licensees (collectively, “Releasees”), and waives, from any liability for injury, loss or damage to persons or property, infringement of any right, or any other claims or courses of action of any kind (collectively, “Losses and Claims”) arising from or relating to Attendees attendance of, and/or participation in, the Event, including but not limited to Losses and Claims caused by the negligence or fault of Releasees. Attendee agrees to indemnify Releasees for any costs, expenses, damages, losses, and/or liabilities (including attorney fees) arising from or related to Attendee’s attendance and/or participation in the Event. In exchange for admission to the Event, Attendee, for themselves and their heirs, representatives, beneficiaries, and assigns, agrees and covenants not to sue (or assist any person in suing) Releasees for any matter related to or arising out of Attendee or Attendee’s guest(s)’ attendance at the Event or any of the Event Terms.

Group Nine reserves the right to refuse entry to, or eject, any person for any reason deemed necessary in the sole discretion of Group Nine for the safe and orderly operation of the Event (including disorderly, vulgar, or abusive conduct) or for the enforcement of policies applicable to the Event (including these Event Terms or other posted policies).

PROGRAMMING, SPEAKERS, DATE AND TIME SUBJECT TO CHANGE AND EVENT IS SUBJECT TO CANCELLATION WITHOUT NOTICE. REGISTRATION IS NON-TRANSFERABLE AND CANNOT BE REDEEMED FOR CASH. Attendee represents and warrants that Attendee owns and possesses all rights to the Submission, including but not limited to all rights to any trademarks, copyrights, and rights of publicity incorporated therein ("Rights") and that Attendee's Submission is wholly created by, and original to, Attendee. By providing a Submission for consideration in the Event, Attendee hereby irrevocably grants to Group Nine and its Affiliates a non-exclusive, royalty-free, fully paid-up, transferable, worldwide, perpetual, irrevocable right and license to display, publicly perform, exhibit, transmit, broadcast, reproduce, record, photograph, digitize, modify, create derivative works, exploit, sell, license, or otherwise use and permit others to use, Attendee's Submission, and the associated Rights contained therein, in perpetuity throughout the universe, in any medium or format now known or hereafter created for any purposes, including for advertising, public relations, and promotional purposes, either in connection with or outside of the Event, without further consent from, or other compensation to, Attendee. Attendee also hereby waives in favor of Group Nine, all moral rights that Attendee may now or later have to Attendee's Submission, throughout the world. Group Nine may freely sublicense, assign, transfer, edit, composite, morph, scan, duplicate, alter, or create derivative works of the Submission for any purpose which Group Nine deems necessary or desirable.

Waiver of Liability

Attendee releases, indemnifies, and holds Group Nine, and the other Releasees from any Losses and Claims which Attendee may ever have in connection with Attendees Likeness.

Attendee, or, in the event Attendee is under 18 years of age, Attendee's parent or guardian (the "Parent"), has read and understood this appearance release and hereby expressly approves and consents to this release of the Likeness, affirms their right and authority to agree to the terms, and waives all obligations and rights which such individual may have in connection therewith. For good and valuable consideration, Parent hereby guarantees that the minor or minors shall not at any time disaffirm the release of the Likeness by reason of the minor's or minors' minority or otherwise and hereby agrees to indemnify Group Nine, and its Affiliates from any loss arising from any claims made by or on behalf of the minors relating to this release of the Likeness.

Age Restrictions

Please note, Group Nine recommends all individuals under 18 attend with an adult, and certain activities such as workout classes will be restricted to individuals ages 18 and up. All individuals under 13 must be accompanied by a parent or legal guardian.

Individuals under the age of 18 must obtain the permission of a parent or legal guardian before sending any information to the Event, entering any sweepstakes or contests at the Event, posting any information on the Event website or related websites, or purchasing any goods online related to the Event. The submission of information to the Event or an RSVP for and/or use of login credentials/link to the Event is a representation and confirmation that you are age 18 or over or have obtained the consent of a parent or legal guardian. Cancellation Policy
